- Shows a passion and commitment for environmental education along with integrity and a strong work ethic
- Innovates environmental education activities and programs
- Contributes to furthering the field of environmental education in New Mexico
- Seeks opportunities for partnerships and collaborations
- Uses a lens of equity and inclusion when developing activities and programs in recognition of our diverse audiences in the Land of Enchantment
